The Local Plan will now be subject to an independent examination which will be conducted by the Planning Inspectorate on behalf of the Secretary of State. The examination is a continuous process running from the submission through to receipt of the Inspector's report. Part of the process will involve public examination hearings where those invited to attend by the Planning Inspector will have the opportunity to respond to matters raised by the inspector. Once the programme for examination is confirmed, including the dates of the public examination hearings, details will be made available online and sent to all those who made representations on the Proposed Submission Local Plan (Regulation 19 stage).
